- Nature of Service:** Professional Organising, Decluttering and Interior Redesign is focused on the client's agenda and is non-judgmental. It is about giving impartial advice or making suggestions that could ease your daily stresses and optimise the space(s) you live or work in. The process can create self-awareness and lead to dramatic life changes.
- Initial Health Check:** Following an initial phone call to determine whether I can assist with your current organisational concerns, we will have an on-site Health Check at your premises (or, if appropriate, via Skype or Facetime) for me to see the scale of the job. The Health Check fee will be offset fully against your package price if you progress with further organising services from SortMySpace and pay a deposit within 30 days of the Health Check.
- Costs:**
- £40 for initial onsite (or Skype / Facetime) Health Check of 1 hour
 - £140 / £160 Sprint Package: 3 hours (off-peak/peak)
 - £240 / £260 Marathon Package: 6 hours (off-peak/peak)
 - £500 / £620 Relay Race Package: 12 hours (off-peak/peak)
 - £800 / £1040 Relay Race Package: 24 hours (off-peak/peak)
 - £30/hr or £35/hr for any additional hours onsite (off-peak/peak)
 - £25/hr hour for any hours offsite (sourcing, researching, planning events)
- All prices quoted are inclusive of VAT. Prices may be subject to increases from time to time but will not impact existing package rates once a deposit has been paid. Current customers will be given at least 30 days' notice of any price increase to allow them to purchase additional packages at the current rates.
- Payment:** Payment is due for your Health Check within 30 days of the appointment. Alternatively, if you decide to purchase a package, an invoice will be raised for your package of choice instead. 40% deposit of the package price is due prior to the first package session. The remaining 60% of your package fees must be settled by the end of the session (or final session for a Relay Race package). Another invoice will be provided for any additional charges (travel costs, storage solutions etc as detailed above). This must be settled within 30 days of the invoice date.
- Cash or cheque (made payable to SortMySpace Ltd) accepted in person.

- Changes & Cancellations:** Under the Consumer Contracts Regulation 2013, you have the right to cancel this contract within the 14 days "cooling off period" from signing these Terms and Conditions. No penalties will be enforced and any deposit paid will be refunded in full. If however any services (including the initial Health Check) have been performed during this "cooling off period" time you will forfeit your right to cancel under this act. Either party has the right to cancel a package session due to unforeseen circumstances. Cancellation should be provided in writing by email. If you need to cancel with less than 2 days (48 hours notice) of the agreed date and time, the full agreed fee* will be levied and payable. If you cancel between 48 hours and 7 days of the agreed date and time, 50% of the agreed fee* is payable. * (or pro-rata for a Relay Race package session) We may waive all or part of these fees at our discretion if the appointment is re-scheduled within 1 month of such cancellation.
- Guarantee:** I am 100% committed to your personal fulfilment, development and success. If after the Health Check or our first 3-hour session you feel that the Professional Organising has not moved you forward towards your goal, let me know within 24 hours and I will give you a full refund, no questions asked.
